Dear Camper and Parents:

Welcome to THE Early Childhood After Camp for Tiny Tots, Camp Innovation and Wiggleworms! We have a great summer planned!

Early Childhood After Camp (ECAC) staff will meet the bus transporting Wiggleworms to ECAC at the southwest door of the Community Recreation Center every day. On Monday, June 14, Roberta Mueller, ECAC Director, will be greeting campers. Each day, staff will escort Camp Innovation and Tiny Tots campers from their Community Recreation campsite to their ECAC classroom. The campers will meet in rooms 126, 127 and 128 each day.

The **Camper Information Data** will be collected online through your household account. The information only needs to be completed once per camper, regardless of how many camps they attend. Moving forward, it will only need to be updated when there is a change in your camper's information.

Camps begin the week of June 14. A copy of the general information parent manual and camp forms can also be found on the park district's website at www.wilmettepark.org/camp-manual-forms.

Please note:

- Starting on June 14, the Roberta Mueller, ECAC Director, can be reached via email at ecaftercamp@wilpark.org. Emails will be checked prior to the start of the camp day and at the end of the camp day and responded to accordingly.
- When picking up, please sign out your child daily before leaving the facility. Pick up is at 6:00pm. Please be prompt.
- Tiny Tots campers must bring a lunch every day. Due to the life-threatening nature of peanut allergies, please refrain from sending anything with nuts. It is your responsibility to pack a daily snack for your child. .
- Early Childhood After Camp campers will have a daily rest/nap time. Each Tiny Tots camper will be assigned their own cot and may bring a blanket, pillow, soft toy and/or books to enjoy during their rest period at 1:00pm. They will be doing quiet activities at that time and cots will be available for campers use. We respectfully require you schedule pick-up after 3:00pm to help us maintain a rest period for the children.
- Early Childhood After Camp campers may participate in classes offered at the CRC after 2:00pm for Tiny Tots, and after 2:30pm for Camp Innovation and Wiggleworm camps. In order to release a child to class, we require a signed Permission to Escort form be submitted before the start of camp.
